On Saturday the 27th of September the Veterinary Surgeon had to put her down, yes shoot her. I had worked, milked and bred her to the best Ayrshire Sire, Yes Beauty was there for the benefit of Veterans and was worth much more than her monetary value of \$3000.

Yes we had built a Cow Barn, bought a Milking Machine, Pasteurizers, Separators, Heated Waterers, Hay, Grain and Fenced Paddocks.

Then all because of Director Jeffery Quarles and his Gang of Eight and the vendetta, lies, deceit and rejection of Transitional Housing for Homeless Native American Veterans we do not have a House Manager or Residents. The House Manager and Residents would have notified the Veterinary Surgeon as soon as Beauty started to look sick and we would probably still have Beauty.

The VA has not provided what was promised, contracted or stated, they have not provided the House Manager/Caretaker that would have kept an eye on the Cow and Chickens while we came back to the Veterans of the Vietnam War, Inc & The Veterans Coalition Headquarters to Fight, Protest and seek a meeting and resolution to the Situation in SD.
